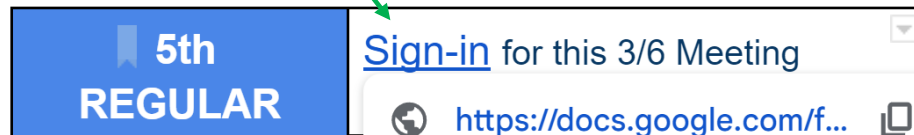
## SIGNING IN:
